Bidder Questions**

**1. Will VDOT require the areas on Kenwick Trail and Hartley Circle that require pavement replacement to be milled prior to the overlay being placed?**

Construction Plans Sheet 3 of 9, Pavement Replacement Detail, add note 6 to read as follows, "Where new pavement meets existing pavement, mill a minimum 12" wide section of the existing surface course and overlay along with the proposed surface course in order to prevent a single vertical cut through the entire section. The milled area will be considered incidental to the pavement replacement area and will not be measured or paid for separately."

**2. Bid Form Page 16, Item #19; It looks like 20 linear feet of 24" RCP Class III pipe between structures D & C was left off the bid form. Will this 20 linear feet be added to the 45 linear feet on the bid form and a revised bid form sent out?**

Replace the Bid Form with the revised Bid Form attached. The quantities in Bid Items #4 and #19 have been revised.

**3. Bid Form Page 16; It is unclear to us what should fall under Item #3 on the Bid Form. Typically excavation for the pipe falls under pipe line item and excavation for the ditch falls under the line item for the Type "A" ditch. Please clarify.**

On the bid Form, Item #3, Excavation, Unclassed, refers to any excavation that might be associated with any work, outside of the VDOT Right of Way, other than pipe installation (Item #s 4 or 5) or installation of the Type "A" Riprap Ditch Item #6).

The undersigned agrees that the following Unit Prices will become a part of the Contract and in accordance with the Contract Documents shall be used for the purpose of adjusting the Contract Sum up or down for changes made by the County for increased or decreased quantities of work from estimated quantities as indicated on the Drawings and/or in the Specifications. The Unit Prices shall include all labor, materials, equipment, services, overhead, profit, insurance, bonds, taxes, etc., to cover the finished work of the several kinds called for in place. There is no guaranteed maximum or minimum amount of the quantities for materials listed below.
