- 2. Clarification of Scope** – This bid is for materials only. Installation will be completed by RCPS, and should not be included in any bid pricing submitted.
- 3. Equivalent Models** – Vendors must bid the models listed in IFB 2020-001 or *equivalents*. Equivalent models will be considered for this project. The inclusion of the specific brand name in the IFB is intended to convey the general style, type, character and quality of the locks sought by the Schools. It is the responsibility of the vendor to effectively verify that another brand and/or model is equivalent to that which is specified in the bid document.
- 4. Specification Clarifications** – Please note the following clarifications of and/or changes to the original bid specifications. In the event of a conflict between the following information and the specifications of IFB 2020-001, the below information shall prevail.
  - Site No. 22, Hidden Valley High School: the 102 mortise locks are part number 8204-JLN-63.
  - The following three locations shall be supplied with X16W keyways: No. 18 William Byrd High School, No. 21 Northside High School, No. 22 Hidden Valley High School.
  - Keys must be serialized, with consecutive numbers.
  - Cores and keys shall be packaged separately, and labeled by location as listed in the bid document.
  - Locations 2, Glenvar High School; and 3, Masons Cove Elementary School, do not require cores.
- 5. Can vendors bid only the cylinder locks requested?**  
Vendors are permitted to submit partial bid responses. Roanoke County/Roanoke County Public Schools reserves the right to award on a partial or whole basis, as is deemed to be in the best interest of the Schools.
