1. Can the county please provide clarification regarding each of the evaluation criteria listed on page 10 of the RFP? In order to be technically acceptable in each of the areas for adequate evaluation by the County, we feel this info would be helpful in formatting our response to you.

For example: 20% of the evaluation rests on Past Experience- could you provide more details regarding what the County considers relevant experience?

For example: Another evaluation criteria is Reliability- would this be reliability of our proposed network solution and would you mean reliable speed and/or service or something else? We want to make sure that we address your concerns regarding Reliability correctly.

Answer:

1. *Network Map/Topology Map and Provider –how you’re proposed services matched the areas of requested services. Note: Proposals for other areas are welcome but there needs to be maps provided for those as well.*
2. *Past Experience -knowledge or skill in the installation & maintenance of broadband/high speed Internet that you have gained because you have provided those services for other users in the past or for a long time*
3. *Reliability -the degree to which the services provided can be depended on to be usable.*
4. *References -Customers who can be asked for information about the proposer’s services, abilities, and quality of work.*
5. *Cost –total cost of the project*
6. *Timeline to Install Services –the time from initiation to availability of services*
7. *Sufficiency -an adequate amount of information, especially of essential details to properly evaluate the proposal.*

2. Request for Proposal price form: Could you please provide me with guidance on how to locate the Request for Proposal price form? The wording on this is unclear as it appears proposals but use the form but that a form isn't available.
