- Ending at Green Hill Park at 3:30.

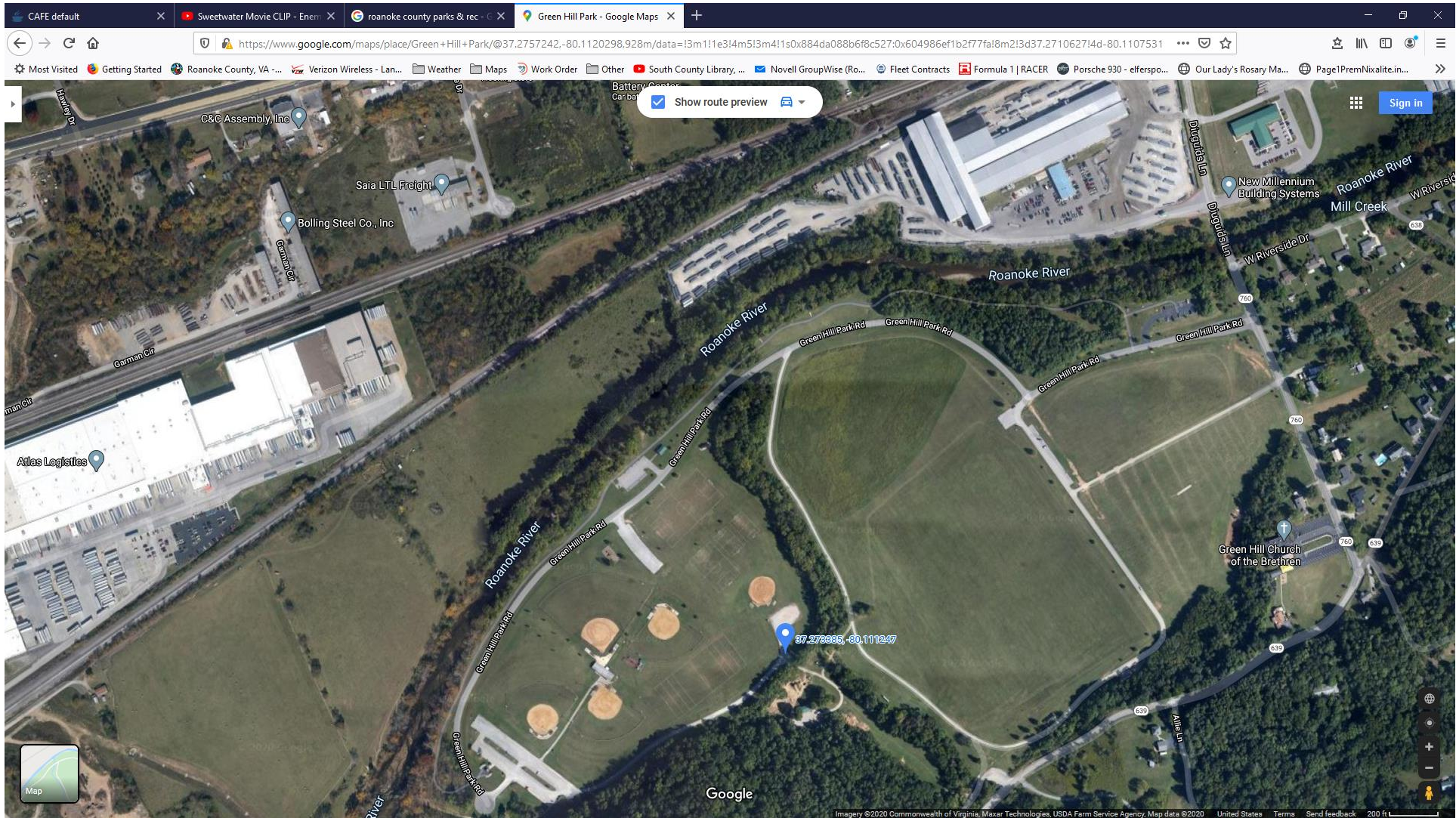
**For Green Hill Park we will meet at the parking area closest to the construction site which is all the way at the back of the park.**
