ADDENDUM NO. 1 TO ALL BIDDERS/OFFERRORS:

Reference – RFP 2021-096

Description: Heavy Duty Aerial Ladder Fire Apparatus

Issue Date: May 11, 2021

Proposal Due: July 12, 2021

The above Project is hereby changed as addressed below:

1. **Responses to Vendor Questions** – Please see below for a list of questions submitted by prospective offerors, and the responses issued by Roanoke County as we are able.
 - a. In section 24.1 the RFP requests 99" overall cab height; Section 17.5 states overall height as low as possible; Section 26.20-26.21 requests flush mounted scene lights fixed above crew windows. This would require a raised roof. Is it acceptable to fix these between front doors and crew doors in order to keep overall length low?
Yes; placing the light between the doors is acceptable. The crew windows between the doors have been eliminated because of the EMS compartments in this location.
 - b. Should cab paint be single tone, two-tone, or match previous Apparatus?
Both cab and body should be solid white, single tone, per Section 38.2.
 - c. Section 26.18 calls for treadplate guards for HiViz or equivalent light bars, over each catwalk. No light bars are called out as such?
There are no light bars on the body of the truck. This is an error on our part; please disregard.
 - d. Section 2.14 states warranty for painted roll-up doors; section 40.10 asks for option pricing. Should this be figured into the proposal or a separate cost?
Painted doors, and the warranty for same, should be priced in 40.10 as an option. This was a last-minute decision to split the painted doors out as an option, and we failed to remove the warranty requirement in 2.14.
 - e. Section 28.12 calls for shelves. For this to be priced correctly, please provide

the number of shelves.

Section 28.11 calls for tracks for shelves in any compartment taller than 16 inches. Please figure one shelf in compartments 16-40" tall, two shelves in compartments more than 40". If the compartment is full height and has two different depths (i.e., deeper on the bottom and shallow on the top), please figure one shelf for each depth. Number and configuration of shelves may need to be adjusted in pre-build, depending on compartmentation configuration submitted.

f. Section 33.2 calls for six (6) tip and tracking lights, but only describes four (4) locations; please advise.

The correct quantity of lights in 33.2 should be four (4); please excuse the mistake.

g. In Section 40.2, Aerial hosebed preferred? (Chutes or Sidebed)

A central hosebed with chute is preferred, to increase compartment space.

h. In Section 35.1 Ground Ladder complement, one (1) 10' Folding step and one (1) 10' attic ladder are listed. Please clarify these.

"10' folding step" is a 10' folding construction-type 1A rated step ladder, either aluminum or fiberglass, such as the Werner 370 series or Werner T6200 series or equivalent.

"10' Attic ladder" is an aluminum folding 10' ladder such as Alcolite FL10 or Duo Safety 585A series, or equivalent.

These model numbers are meant to offer examples of type, and are not the only acceptable models.
