East Roanoke River Greenway Gap Survey

Thank you for taking the time to complete this survey. Please review the "East Roanoke River Greenway Gap Community Meeting Display" when answering these questions.

Roanoke County staff began working in 2013 on the "Original Greenway Concept," with the greenway located closer to the Roanoke River to reduce impacts to property owners. This concept can no longer be built as shown because of a change in regulations that requires the greenway to have no steeper than five percent grade, or slope, to provide a better experience for users with disabilities. This concept is also expected to flood every year.

The "Proposed Greenway Concept" is located at a higher elevation which is unlikely to flood, and will meet the new grade requirements which results in the greenway having fewer steep sections. Two optional bridges are also shown as part of this concept.


