2. Vendor Inquiries: Please see below for a list of questions submitted by prospective Bidders, and the responses provided by RCPS as we are able.
 - a. Who has BAS controls on the chiller, and can you provide name and contact info?

 - b. Will new refrigerant piping be required?
Yes, Bidders will be required to replace the refrigerant piping. This cost should be included in the bid price.
 - c. Will new filter dryers or site glasses be needed for liquid refrigerant piping?
Yes.
 - d. Will new chilled water shutoff isolation valves be required? If so what type of valves?
No.
 - e. The existing outdoor refrigerant piping wasn't insulated; do we need insulation on outdoor refrigerant pipe? If so, please provide specs on type of insulation and type of covering. It is not specifically stated on the scope of work.
Contractor should provide neoprene insulation only on the suction line, per the original setup.
 - f. Will contractor be responsible for refrigerant monitoring and refrigerant emergency exhaust system for chiller/boiler room and interlock with existing heating equipment?
No.
 - g. Will crane work need to be done during off school hours?
Yes, crane work will need to take place outside of normal school hours.

- h. Will chilled water balancing be required limited to chiller room?
No.
 - i. Does chilled water system have glycol in it? If so what type and percentages?
No.
 - j. Does owner want to keep any of existing refrigerant? If so, who provides removal and refrigerant recovery cylinders?
Yes, RCPS wishes to keep the refrigerant, and RCPS will provide cylinders.
