- 1) The How do we handle the structure at 2050 Denise Circle?
 - a. Please See Separate Downloadable Attachment titled “**2023-065 - IFB - Denise Circle Project Modified Drawings - Full Set 3-7-23**”
- 2) Is it ok to core drill wingwall instead of pre-casting pipe penetration?
 - a. Yes, coring the penetration for the 15" RCP into the wingwall is acceptable.
- 3) Why are there two different bid items for trench backfill and restoration in paved areas?
 - a. Two pavement cut and restore options are detailed on the revised downloadable plans titled “**2023-065 - IFB - Denise Circle Project Modified Drawings - Full Set 3-7-23**” one for VDOT Right of Way, and one for private driveways.

4) Limits of paving at 2044 Denise Circle driveway?

- a. Revised downloadable plans titled “**2023-065 - IFB - Denise Circle Project Modified Drawings - Full Set 3-7-23**” plans call for replacing pavement all the way to house #2044.

5) Will a SWPPP be required?

- a. No SWPPP is not required since the disturbed area is under one acre. Roanoke County will obtain the Grading Permit and VDOT Land Use Permit.

6) Will storm drains get a video inspection?

- a. Existing storm drains can be video inspected by the Contractor at Contractor's option. New storm drainage will require video inspection upon completion.

7) NOTE: Roanoke County **will Clear** but **Not Grub** the area at the 48” Wingwall.
