 - a. **To clarify Qualification Statement, Paragraph 7, Specialized Construction Experience:**

“Stream restoration” or “bioengineered streambank stabilization”, for the purposes of this bid are defined as projects whose primary purpose is to restore stable natural function or stability to a stream system by re-shaping the stream’s bed and/or banks, planting native woody vegetation (trees and/or shrubs) and using other natural materials such as boulder-sized rocks and logs to construct structures in the stream that re-direct flows and protect streambanks. These projects are distinguished by their

extensive use of natural and native materials including plants as part of the construction, and the requirement of equipment operators to have specialized knowledge and experience in the construction and configuration of flow re-direction structures such as cross-vanes, log vanes and similar structures.

Projects that include work to stabilize streams using traditional means of rock rip rap or other hard stabilization do not meet the definition of acceptable stream restoration projects for the purposes of qualifying for this project
