 - a. The contractor is not responsible for any reinstallation of landowner patio or other structures other than foot bridges. If foot bridges are disturbed, they shall be repaired to existing or better condition and reset in the original location. The project team will coordinate with landowners prior to construction to allow owners to salvage other (non-bridge) materials as they see fit.
